### **PURPOSE**

That the Ningaloo Tourism Advisory Group (NTAG) as a Committee of Council:

- Elect a Chairperson and Deputy Chairperson; and
- Consider revising the NTAG Terms of Reference (TOR) to include a representative from the Department of Transport.

If approved both of the above to then seek endorsement from Council.

### **BACKGROUND**

The *Local Government Act 1995* Section 5.8, 5.9 and 5.10 empowers Council to establish committees and elect persons to serve on those committees.

Council approved the establishment of the Ningaloo Tourism Advisory Group (NTAG) at the 26 September 2019 Ordinary Council Meeting (Attachment 1 OCM minutes including TOR).

A requirement of the NTAG is to elect a Chairperson and Deputy Chairperson from within the advisory group both for a two year period.

As stated in the TOR the Chairperson will be appointed from amongst the Advisory Group as elected by the voting members of the group and endorsed by Council.

The TOR also lists a number of stakeholder agencies to be invited to nominate a representative to participate on the NTAG. These agencies include the Department of Biodiversity Conservation and Attractions, Exmouth Chamber of Commerce and Industry, Australia's Coral Coast, Tourism WA, and the Gascoyne Development Commission.

Since drafting the TOR, it is the officer recommendation to also include a representative from the Department of Transport.

### **COMMENT**

A Chairperson and Deputy Chairperson are required to be elected from the NTAG and then endorsed by a resolution of Council.

The NTAG has been asked to consider and endorse the NTAG Terms of Reference. An officer recommendation is to revise the TOR to include a representative from the Department of Transport. This representation is considered essential to reflect the importance access issues and infrastructure (road, air and water) to and through the Ningaloo destination.
